## Chairperson

- 3. Knowledge and experience of not less than seven (7) years in audit and/or financial Management/ Accounting.
- 4. Knowledge and experience in Public Service /Devolved system of Government including operations, financial reporting and auditing.
- 5. Knowledge and experience in Risk Management.
- 6. Be a person of integrity and in compliance with requirements of chapter six of the constitution of Kenya 2010.

#### Members

- 1. A degree from a university recognized in Kenya.
- 2. Progressive working experience of not less than five (5) years.
- 3. Be a member of professional body and in good standing.
- 4. Knowledge and experience in Public Service /Devolved system of Government including operations, financial reporting and auditing.
- 5. Be a person of integrity and in a compliance with requirements of chapter six of the constitution of Kenya 2010.

## Terms of appointment.

- i. Members of the Audit Committee shall be appointed for a term of three (3) years on part time basis and shall be eligible for re-appointment for a further one term only.
- ii. Despite the provision in (i) above, after the expiry of every term at least one third of the committee shall retire and shall not be eligible for re-appointment.
- iii. The term is only extended after the performance of the committee has been reviewed.
- iv. Applicants should not be past or present employees of the County Government and shall not have served as an employee or agent of a business organization which has carried out any business with the County Government.
- v. Applicants should not be political office holders
