ACTION PLAN 2019-2020

Introduction.

Vihiga Municipality is one of the Municipalities in Kenya and is located within Vihiga County. Vihiga Municipality is located within Vihiga and Sabatia sub-counties in Vihiga County and is approximately 25km from Kisumu City to the south and 32km to the north from Kakamega town. Mbale town is about 381km from Nairobi City. The Municipality has area coverage of 78km2. Geographically it lies between 0o 03′ and 0o 15′ North, 34o 41′ and 34o 48′ East. Vihiga Municipality was one of the three local authorities found within the former Vihiga District. Urban Areas and Cities Act, 2012 recommends that a township with a population of more than 50,000 and less than 250,000 people qualifies to be classified as a municipality.

Drawing on the skills and deliberations at Ciala Resort, we need to pursue options which facilitate the pursuit of sustainable urbanization in Vihiga Municipality. Therefore, achieving an endogenous growth trajectory which is environmentally sustainable, socially just and economically inclusive will require active commitment on the part of the County government, the County Assembly, the Municipal Boards & its Administration, the urban residents, stakeholders and other institutional role-players which parallel and support urban citizens to engage more effectively in a process of jointly finding solutions to the challenges of urban growth and development.

- Coping with the rapidity of both change and growth is and will increasingly prove to be a significant challenge for Vihiga Municipality, its urban areas and their residents
- Within this context citizen participation, sound urban governance and accountability, the pursuit of environmental and resource sustainability and inclusive economic development and employment creation are critical if we are to ensure a just and sustainable urban future for Vihiga Municipality.
- At a broader level 2020 is a crucial year in terms of implementation of County Urban Institutional Development Strategy (CUIDS) as it will witness the transformation and classification of urban areas into markets, towns and municipalities.
- As part of the on-going Board induction and bonding, our collective urban future, continual dialogue and debate is essential to help ensure the sound evaluation of evidence, the interrogation of new interventions and the derivation of the most appropriate policy support from the County Government and the County Assembly.

- Urban decentralization and legislative reform.
